

TERMS AND CONDITIONS – RIVER 94.9'S RENOVATION RUMBLE

- 4. Who can enter** Entry is open to everyone residing within the River 94.9 broadcast area.
Entrants must not be the employees or the immediate family members (spouse; de facto spouse; or natural, adopted or step, parent, child, or sibling) of the employees of the Promoter, the Prize provider(s), of any of the suppliers or agencies associated with this competition, or of any of the related bodies corporate (as that term is defined in s50 of the *Corporations Act 2001 (Cth)*) of the Promoter, the Prize provider(s), or of those suppliers or agencies.

(Eligible Entrants)

- 10. Prize Draw** Minor – on conclusion of each 'Round', one (1) entrant that has voted on the winning product of that round will be chosen at random as that round's winner.
- Major – once renovations are complete at the River 94.9 office, an Office Warming Party will be held. This is where the major winner will be drawn at random to win the \$7,500 major prize. The Office Warming Party will not take place any later than 31st March 2020. This major winner will be notified by email and/or phone.

- 11. Notification of winner** Minor – each Round Winner will be notified by email and/or phone. The winner themselves are the only one who can collect the prize from the River 94.9 office.
